# **Electoral Commission of Queensland** Disclosure Return - Donor to Candidate

(Redcliffe By-election Saturday 22 February 2014)

The Electoral Act 1992 requires that a person who makes political donations or other gifts fotalling \$1,000 or more to the same candidate must give the Electoral Commission of Queensland a return in this approved form.

The disclosure period starts from Tuesday 24 April 2012 and ends Monday 24 March 2014. Returns must be lodged by Tuesday 10 June 2014.
