The purpose of this chapter is to provide police	19
officers with special powers during the Games	20
major event period to promote—	21

- (a) the safety and security of persons attending
any event, function or activity that is part of
the Commonwealth Games; and
- (b) the safety of other members of the public.

619F What is a *protective security zone* 18

619G Prescribing protective security zones

- (1) A regulation may prescribe an area of land or water, other than a Games major event area, to be a protective security zone for a stated period.
- (2) The protective security zone prescribed under subsection (1) must be shown on a map in the regulation.
- (3) The map, showing the exact location of the boundary of the protective security zone, must be able to be accessed, free of charge, on the designated website.
- (4) The exact location of the boundary of the protective security zone must be held in digital electronic form by the department.

619H Declaring protective security zones

- (1) The commissioner may by written order (a *zone order*) declare an area of land or water, other than a Games major event area, to be a protective security zone for a stated period.
- (2) However, the commissioner may declare an area to be a protective security zone only if the commissioner is reasonably satisfied—

| <ul style="list-style-type: none"> (a) the declaration is necessary for the safety and security of persons entering or in the area; and (b) the Games major event organiser has been advised of the proposed declaration; and (c) urgent action is required to declare the area to be a protective security zone. <ul style="list-style-type: none"> (3) The commissioner must obtain the Minister's approval to declare an area to be a protective security zone unless the commissioner is reasonably satisfied a delay in obtaining the Minister's approval would be likely to substantially compromise the safety and security of persons entering or in the area. (4) If the commissioner makes a zone order without the Minister's approval, the commissioner must inform the Minister about the making of the order and its terms as soon as practicable after the order is made. (5) A zone order has effect when it is published on the designated website or at a later time stated in the order. (6) The Minister must table a zone order in the Legislative Assembly within 14 sitting days after the order is made. (7) A failure by the Minister to table a zone order under subsection (6) does not affect the order's validity. | <p>1

Division 1 Power to search 7

619J Power to search persons 8

- (1) This section applies to a person entering or in a 9
protective security zone. 10
- (2) A police officer may stop and detain the person to 11
do either or both of the following— 12
 - (a) conduct a frisk search of the person; 13
 - (b) inspect an article in the person's possession. 14
- (3) For subsection (2), the police officer may use an 15
electronic detection device, including a metal 16
detector, on the person or the person's 17
possessions. 18
- (4) If reasonably practicable, the police officer must, 19
before conducting a frisk search of the person or 20
inspecting an article in the person's possession— 21
 - (a) give the person a reasonable explanation 22
about the powers to be exercised; and 23
 - (b) ask for the person's cooperation. 24
- (5) Sections 624 to 626, 628 and 637 apply to a search 25
of a person or an inspection of an article in the 26
person's possession under this section. 27
- (6) In this section— 28

619K Power to stop, detain and search vehicles 2

- (1) A police officer may— 3
 - (a) do either of the following— 4
 - (i) stop a vehicle entering or in a 5protective security zone; 6
 - (ii) detain a vehicle in a protective security 7zone; and 8
 - (b) require the person in control of the vehicle 9to allow it to be searched. 10
- (2) For searching the vehicle, a police officer may do 11any of the following— 12
 - (a) detain the vehicle and the person in control 13of the vehicle for as long as is reasonably 14necessary to conduct the search; 15
 - (b) move, or require the person in control of the 16vehicle to move, the vehicle to a place 17suitable to conduct the search; 18
 - (c) search any thing in or on the vehicle and for 19that purpose open (including by using force 20to open), or require the person in control of 21the vehicle to open, a part of the vehicle or 22any thing in or on the vehicle; 23
 - (d) undertake an electronic inspection or search 24of the vehicle, including, for example, with 25a machine known as a Backscatter van. 26
- (3) Sections 627 and 628 apply to the search of a 27vehicle under this section. 28

619L Power to enter and search premises 29

- (1) A police officer may enter and search any 30premises in a protective security zone without a 31warrant. 32

- (2) For subsection (1), the police officer must use only the amount of force reasonably necessary in the circumstances.

 - (3) However, subsection (1) does not authorise a police officer to enter premises, or a part of premises, where a person resides (a **residence**), other than—

 - (a) with the consent of the occupier of the residence; or
 - (b) if a police officer reasonably suspects an offence may be committed in or from the residence and the offence would be likely to endanger the safety of a person.

 - (4) The following do not form part of a residence—

 - (a) a carport, other than a carport to which access is restricted;
 - (b) the area of a verandah or deck to which access is not restricted and no provision is made to restrict access;
 - (c) the area underneath the residence to which access is not restricted and no provision is made to restrict access;
 - (d) any other external part of the residence, including, for example, the residence's gutters;
 - (e) land around the residence.
