A regulation may prescribe criteria (the *accreditation criteria*), relevant to a school's accreditation, about the following—

- (a) the school's administration and governance arrangements;
- (b) the school's financial viability;
- (c) the school's educational program;
- (d) the school's student welfare processes;
- (e) the school's resources;
- (f) the school's improvement processes.
