1. Introduction

1.1 Role of the Committee

The Legal Affairs and Community Safety Committee (committee) is a portfolio committee of the Legislative Assembly. It commenced on 27 March 2015 under the *Parliament of Queensland Act 2001* and the *Standing Rules and Orders of the Legislative Assembly* (Standing Orders).¹

The committee's primary areas of responsibility include the portfolio areas of:

- Justice and Attorney-General
- Police
- Fire and Emergency Services
- Training and Skills.

Section 93(1) of the *Parliament of Queensland Act 2001* provides that a portfolio committee is responsible for examining each Bill and item of subordinate legislation in its portfolio areas to consider:

- the policy to be given effect by the legislation
- the application of fundamental legislative principles to the legislation
- for subordinate legislation its lawfulness.

In considering the application of fundamental legislative principles and lawfulness, portfolio committees consider similar situations issued by the former Parliamentary Scrutiny of Legislation Committee, which undertook this function prior to the commencement of standing portfolio committees in 2011; and from the Office of Queensland Parliamentary Counsel, which has statutory responsibility for advising on the application of FLPs to proposed legislation.

1.2 Subordinate legislation examined

This report advises of subordinate legislation examined and, where applicable, presents any concerns the committee has identified in respect of subordinate legislation tabled between 13 January 2015 and 5 May 2015. The relevant legislation is summarised in the table below.

2. Subordinate legislation examined

The committee reports on the following policy, fundamental legislative principle or lawfulness issues:

2.1 SL 317 – Proclamation made under the Safe Night Out Legislation Amendment Act 2014

The committee noted an apparent error in the Explanatory Notes to the proclamation. The proclamation states 19 December 2014 as the commencement date for certain provisions of the *Safe Night Out Legislation Amendment Act 2014*. The Explanatory Notes state the commencement date as 12 December 2014. This occurs in the first paragraph under "Policy objectives and reasons for them" and the first paragraph under "Achievement of Policy Objectives". The committee has written to the relevant department accordingly.

2.2 Communities, Disability Services and Domestic and Family Violence Prevention Committee

The committee notes the potential relevance of the subject matter of subordinate legislation 284, 321 and 322 of 2014 to the portfolio of the Communities, Disability Services and Domestic and Family Violence Prevention Committee (CDSDFVP Committee). The committee invited the CDSDFVP Committee to provide written comment on any matters relating to domestic and family violence.

In its written response to the committee dated 10 June 2015, the CDSDFVP Committee advised:

- no potential issues of fundamental legislative principle were observed in subordinate legislation 284 or 321; and
- it was satisfied as to the justification for the potential breach of the fundamental legislative principle that subordinate legislation should contain only matters appropriate to that level of legislation (section 4(5)(c) of the *Legislative Standards Act 1992*), which had been identified in subordinate legislation 322, Domestic and Family Violence Protection Rules 2014, rule 24 authorising a court order or direction to override statutory rules.

Recommendation 1
