MR SPRINGBORG asked the Attorney-General and Minister for Justice (Mr Welford) –

QUESTION:

With reference to Legal Aid funding for each of the last two financial years and for the year to date (reported separately):

- (1) What is the total amount of funding provided for legal cases for Brisbane and each regional office in Queensland (reported separately)?
- (2) What is the total number of applications made for legal aid funding for Brisbane and each regional office in Queensland (reported separately)?
- (3) For those applications listed in (2), what is the total number of applications approved for Brisbane and each regional office in Queensland (reported separately)?

ANSWER:

(1) The funding provided to private solicitors to undertake legal aid casework for each regional office is listed in the table below. It includes the value of casework provided by Legal Aid Queensland's in-house legal practice.
