Revised Response Question on Notice

Asked on 23 March 2005

MISS SIMPSON asked the Minister for Transport and Main Roads (MR LUCAS)—

QUESTION:

With reference to budgeted and approved capital works for each department, agency and portfolio entity administered by him—

- (1) What capital works projects are running behind schedule or have not been commenced or completed to date (reported separately according to name and location)?
- (2) For each of the projects listed in (1), what is the amount expended to date and what level of expenditure is still budgeted to complete each project?
- (3) For each of the projects listed in (1), what is the revised completion date and the Corresponding reason why?

ANSWER:

The response to this Question on Notice has been prepared taking into account those works described in the 2004-05 Capital Statement. Capital projects include contingencies as they can be affected by implementation and delivery delays.

The response for Transport and Main Roads are as outlined below.

Main Roads

2,502 Main Roads projects are published in the 2004-05 to 2008-09 Roads Implementation Program (RIP), with some 1,600 incurring expenditure in the 2004-05 financial year.

The performance by Main Roads in delivery of roads projects is published each year in the "Performance Indicators and Established Targets for the Roads Program" section of the annual RIP at Appendix 7. The relevant indicators provide a summary of:

- the proportion of the number of projects (greater than \$1m) completed within 10% of the programmed construction period
- the proportion of the number of projects (greater than \$1m) for which construction commenced within four months of the programmed commencement date.

In a Question without Notice on 24 May 2005, the Member for Maroochydore claimed that the "Icebox" road project between Maleny and Landsborough had "...escalated in cost <u>from</u> \$2.6 million <u>to</u> well over \$11 million." Ms Simpson was referring presumably to an article in the "Range News" of 12 May which stated that "...the project soared <u>by</u> \$2.6 million <u>to</u> \$11.1 million...". Ms Simpson also repeated this incorrect assertion in her media release which was issued on the 24 May.

According to performance targets published in the RIP over many years, this project was not materially delayed at this time. The cost of the project increased \underline{bv} \$2.6m – from \$8.5m to \$11.1m primarily due to the need for the additional slope stabilisation work arising from the steep and unstable ground above the road. This information is also published in the RIP.

Budgeted expenditure for 2004-05 for the following roads projects which are materially delayed represents less than 11% of the overall Main Roads capital program, with the delayed expenditure representing less than only 2% of the overall capital program. Clear and valid reasons exist for these delays as at end of March 2005 (see separate note for Sunshine Motorway), the details of which are outlined below.
