**Asked on 21 February 2007**

MR CRIPPS asked the Minister for State Development, Employment and Industrial Relations (MR MICKEL) —

QUESTION:

With reference to the *Regional Business Development Scheme Cyclone Larry Special Program* —

- (1) How many grants have been awarded under Stage 1 of the program (providing a breakdown of grant recipients and the value of each grant received)?
- (2) How many grants have been awarded under Stage 2 of the program (providing a breakdown of grant recipients and the value of each grant received)?

ANSWER:

- (1) As at 21 February 2007, 272 grants have been awarded under Stage 1 of the program totalling \$2,501,057. Please refer to Attachment A for a breakdown of grant recipients and the value of each grant.
- (2) As at 21 February 2007, five grants have been awarded under Stage 2 of the program totalling \$214,300. Please refer to Attachment B for a breakdown of grant recipients and the value of each grant.
