Thank you for your letter of 25 June 2010 regarding proposed overseas travel to South East Asia from 13 to 31 July 2010.

You have sought my approval for overseas travel to Shanghai and Guangdong, to be overseas travel pursuant to the *Guidelines for the Financial Management of the Office of the Speaker* (the guidelines).

I also note that you have sought my approval for the payment of Overseas Daily Travelling Allowance (OSDTA) for part of your travel pursuant to the *Members' Entitlements Handbook* (the handbook), and that as required by the handbook you have written to the Clerk of the Parliament (the Clerk) about this matter.

With respect to your OSDTA claim, I have received advice from the Clerk that he has reviewed your letter and that he supports the payment of three days OSDTA representing two days in Hong Kong (20–21 July 2010) and one day in Singapore (30 July 2010).

In accordance with the handbook, I have written to the Clerk advising him that I have accepted his advice, and that I approve the payment of three days OSDTA.

Turning to your request for approval for overseas travel pursuant to the guidelines, I have received advice from both the Clerk and the Department of the Premier and Cabinet regarding this matter.

In short this advice is similar, and it provides that given your claim for the payment of OSDTA under the handbook, any approval for overseas travel under the guidelines should be limited to travel to and within Shanghai and Guangdong (13–19 July 2010), with the remainder of the trip (i.e. airfares returning to Australia) to be met personally by you in accordance with the OSDTA principles set out in the handbook. I have accepted this advice.



Therefore, while I approve your overseas travel pursuant to the guidelines, this approval is limited to your travel to and within Shanghai and Guangdong. I have written to the Clerk informing him of same, and in accordance with the guidelines, I have asked the Clerk to table your request together with my approval as soon as possible.

I also note that during your visit to Malaysia you plan to undertake certain travel sponsored by Santos and that this sponsored travel will be registered on the Register of Members' Interests. Given that you intend to accept this travel and accommodation; I believe it would be prudent for you to refrain from making any representations on behalf of the Santos Company to any Queensland Government minister or senior departmental officer. I will also advise the relevant ministers of this view.

I have also noted your advice that the Deputy Speaker, Mr Jason O'Brien MP, will be Acting Speaker while you are overseas.

Dear Premier

In accordance with the Guidelines for the Financial Management of the Office of the Speaker, I seek your approval for an overseas trip that I propose to undertake next month.

I have been invited by Mr Liu Yungeng, Chairman of the Standing Committee of the Shanghai Municipal People's Congress, to visit the World Expo currently being staged in Shanghai. The proposed visit is from Thursday 15 July to Sunday 18 July. The objective of the visit to the World Expo is to represent the Queensland Parliament at the event, and to formally demonstrate support for the relationship between Queensland and China through acceptance of the invitation from the Shanghai People's Municipal Congress.

Following the World Expo visit, I will travel to Guangzhou to meet with representatives of the Guangdong People's Congress, including the Hon Mr Ou Guangyuan, Chairman, Standing Committee, Guangdong Provincial People's Congress. This visit and meeting is at the request of Mr Ren Gongping, Consul-General of the People's Republic of China in Brisbane. It follows the visit I made last year and is an advance of a delegation visit from the Province to Queensland later this year.

I also propose to visit Hong Kong where I will meet with the President of the Legislative Council, Mr Jasper Yok Sing Tsang, and also the Convenor of the Executive Council of Hong Kong. This visit will include briefings on the Hong Kong Government's Education City and a major LNG terminal project in Macau, an inspection of the QIMR's cancer research facility at the Queen Mary Hospital and University, meetings in relation to coal and energy issues and also a meeting with the China National Electronic Import and Export Corporation.

In Malaysia, I will visit Bintulu and meet with the Bintulu Development Authority and Bintulu Port Authority, as well as inspect the Petronas LNG complex. The Bintulu visit is being sponsored by Santos, who are meeting the costs and expenses involved. I will as a matter of course be registering relevant information concerning this visit in the Register of Members' Interests, in accordance with the guidelines.

On my return from Bintulu to Kuala Lumpur, I intend to undertake a visit to Vietnam from Sunday 25 July to Thursday 29 July, but this will be in a private capacity and I am not seeking any travel allowance or any other payment of costs or expenses in relation to this component of my trip.

On Friday 30 July I will meet with the Speaker of the Singapore Parliament, Mr Abdullah Tarmugi, undertake a tour of the Parliament, and also meet with the Australian High Commissioner to Singapore for a briefing on trade issues, and visit the Singapore campus of the James Cook University.

My visit to the World Expo in Shanghai and to Guangdong is in an official capacity, and pursuant to the Guidelines for the Financial Management of the Office of the Speaker I seek your approval for this component of my trip as official travel, and approval for travel costs, accommodation and other expenses. The estimated costs associated with this component of the trip are \$4000 (with flights to be booked economy class).

Aside from the visit to Vietnam, the remainder of my overseas trip is being undertaken in my combined capacity as Speaker and also as a Member of Parliament. I seek approval for the Overseas Daily Travel Allowance for the number of days for which I am eligible, in accordance with the provisions contained in the Members' Entitlements Handbook, with the exception of the Bintulu visit.

I have attached for your information a copy of my trip schedule. I am providing a copy of this letter to the Clerk of the Parliament for separate advice to you in terms of the number of days for which approval of the Overseas Daily Travel Allowance is recommended in accordance with Members' entitlements regarding overseas travel.

The Deputy Speaker, Mr Jason O'Brien MP, will be Acting Speaker while I am overseas.
