	(1) The committee must decide to—	27

-
- (a) transfer its assets and liabilities to an eligible entity; and
 - (b) abolish itself.
 - (2) For subsection (1)(a), the committee must decide the following—
 - (a) the day on which it proposes to transfer its assets and liabilities (the *proposed transfer day*);
 - (b) the eligible entity to which it proposes to transfer its assets and liabilities (the *proposed transferee*).

29 Eligible entity

- (1) An entity is an *eligible entity* only if—
 - (a) the entity is any of the following—
 - (i) an incorporated association;
 - (ii) a public company, other than a public company that has a share capital;
 - (iii) a non-trading cooperative; and
 - (b) the entity is not an industrial association; and
 - (c) the entity has, by notice to the committee signed by an authorised person for the entity, agreed to the transfer; and
 - (d) the entity’s constitution or rules are consistent with the entity promoting the interests of the chicken meat industry in Queensland.

(1) The committee must give the Minister notice (the <i>committee notice</i>) of its decision under section 28.	7 8 9
(2) The committee notice must state the following—	10
(a) the date the decision was made;	11
(b) the proposed transfer day;	12
(c) the proposed transferee’s name;	13
(d) that the committee is satisfied the proposed transferee is an eligible entity.	14 15
(3) The committee notice must be accompanied by a copy of the notice mentioned in section 29(1)(c).	16 17
31 Minister’s decision about committee notice	18
(1) The Minister must consider the committee notice and approve or refuse to approve the proposed transfer.	19 20 21
(2) If the Minister considers that all requirements for this division have been complied with for the proposed transfer, the Minister must—	22 23 24
(a) give the committee a notice (an <i>approval notice</i>) approving the proposed transfer; and	25 26
(b) declare the transfer day and transferee by gazette notice.	27 28
(3) If the Minister does not consider that all requirements for this division have been	29 30

- complied with for the proposed transfer, the Minister must— 1

 - (a) give the committee a written direction about compliance with the requirements, including, for example, a direction to give the Minister stated information; or 3

 - (i) refusing the proposed transfer; and 8
 - (ii) giving the reasons for the refusal. 9
 - (4) The committee must comply with a direction given under subsection (3)(a) within the reasonable time stated in the direction. 10

32 Minister’s decision if no approval notice given 13

- (1) This section applies from the day that is 6 months after the commencement if the Minister— 14
15
 - (a) has not given the committee an approval notice; and 16

 - (b) is not considering a committee notice; and 18
 - (c) has not, under section 31(3)(a), given the committee a written direction for which the time for compliance has not expired. 19

- (2) The Minister must— 22
 - (a) decide the day on which the committee’s assets and liabilities will be transferred; and 23

 - (b) decide the eligible entity to which the assets and liabilities will be transferred; and 25

(1)	A certificate signed by an authorised person for the transferee is evidence that an asset has become an asset of the transferee on the transfer day if the certificate—	22 23 24 25
(a)	identifies the asset; and	26
(b)	states the asset was, immediately before the transfer day, an asset of the committee; and	27 28

- (c) states that, under this division, the asset became an asset of the transferee on the transfer day.
 - (2) If the certificate is given to an entity with registration functions under a law of the State for assets of that kind, the entity must do the following as if the certificate were an appropriate instrument of transfer of the asset—
 - (a) register the matter in the same way as transactions for assets of that kind;
 - (b) deal with, and give effect to, the certificate.

Example of an entity with registration functions—
the registrar of titles
 - (3) A transfer of the asset to the transferee may be registered or given effect under a law of another State or the Commonwealth if—
 - (a) the certificate is given to an entity with registration functions for assets of that kind under the law; and
 - (b) the entity is permitted by law to do so.

36 Abolition of committee 22

- (1) This section takes effect immediately after the committee’s assets and liabilities are transferred to the transferee under section 33(1).
- (2) The committee is abolished and its members go out of office.
- (3) No compensation is payable to any person because of subsection (2).

(1) This section applies to a dispute about an agreement or a proposed agreement if—	3 4
(a) the dispute arises on or after the commencement; or	5 6
(b) the dispute arose before the commencement and has not, by the commencement—	7 8
(i) been resolved by the parties; or	9
(ii) been resolved by mediation under section 23 of the pre-amended Act; or	10 11
(iii) been referred to arbitration under section 24 of the pre-amended Act.	12 13
(2) Despite any provision in the agreement, the committee must refer the dispute to an arbitrator appointed by the committee.	14 15 16
(3) However, the arbitrator must not be appointed without the agreement of the parties to the dispute.	17 18 19
(4) If the parties have not agreed to the appointment by the transfer day, the dispute is taken to have ended.	20 21 22
(5) If the parties agree to the appointment, the <i>Commercial Arbitration Act 2013</i> applies to the arbitration.	23 24 25
