**10 Suitability of person to hold approval**

- (1) In deciding whether a person is a suitable person to hold, or to continue to hold, an approval the chief executive may have regard to, and may make inquiries about, the following—
  - (a) the person’s qualifications and experience;
  - (b) the person’s character and standing;
  - (c) the person’s criminal history but only to the extent it is relevant to the application;
  - (d) whether the person engages, or has engaged, in conduct that risks, or is likely to risk, medicinal cannabis being used for a purpose that is unlawful under a law of a State or the Commonwealth;
  - (e) the person’s knowledge and understanding of the applicant’s obligations under this Act;
  - (f) whether the person, in the chief executive’s reasonable opinion, will be able to comply with—
    - (i) this Act; and
    - (ii) the conditions proposed to apply to the approval;
  - (g) whether the person—
    - (i) has held a similar instrument under a relevant law that was suspended, cancelled or had conditions imposed on it; or
    - (ii) has been refused a similar instrument under a relevant law.

  - (j) the individual responsible for making, implementing and reviewing the plan. 13
