## 1 Introduction

### 1.1 Role of the committee

The Economics and Governance Committee (the committee) is a portfolio committee of the Legislative Assembly.<sup>1</sup> The committee's areas of portfolio responsibility are:

- Premier and Cabinet, and Trade
- Treasury, and Aboriginal and Torres Strait Islander Partnerships, and
- Local Government, Racing and Multicultural Affairs.<sup>2</sup>

The committee also has oversight functions in relation to the Queensland Audit Office, the Integrity Commissioner, and the Family Responsibilities Commission.

On 12 June 2018, the Appropriation (Parliament) Bill 2018 and the estimates for the committee's areas of responsibility were referred to the committee for investigation and report.<sup>3</sup> The committee conducted a public hearing on 24 July 2018 and took evidence about the proposed expenditure from the Speaker of the Legislative Assembly.

### 1.2 Aim of the report

This report summarises the estimates referred to the committee and highlights some of the issues the committee examined. The committee considered the estimates referred to it by using information contained in:

- budget papers
- answers to pre-hearing questions on notice
- evidence taken at the hearing, and
- additional information given in relation to answers.

Prior to the public hearing, the committee provided the Speaker of the Legislative Assembly with questions on notice in relation to the estimates. Responses to all questions were received.

The minutes of estimates meetings, correspondence about requests for leave to attend and ask questions, pre-hearing questions on notice and answers, documents tabled at the hearing, questions taken on notice at the hearing and answers, and additional information provided by the Clerk of the Parliament after the hearing are included in a volume of additional information tabled with this report.

### 1.3 Other Members' participation

The committee gave leave for other Members to participate in the hearing pursuant to Standing Order 181(e).

## 2 Recommendation

### **Recommendation 1**

The committee recommends that the proposed expenditure, as detailed in the Appropriation (Parliament) Bill 2018, be agreed to by the Legislative Assembly without amendment.

### 3 Legislative Assembly and Parliamentary Service

The Legislative Assembly of Queensland consists of 93 Members who discharge a range of important legislative and constituency responsibilities.

The Parliamentary Service, established by the *Parliamentary Service Act 1988*, provides administrative and support services to the Legislative Assembly to support, promote and strengthen the Legislative Assembly to fulfil its role in the institution of Parliament.

The Parliamentary Service's strategic objectives are to:

- support the Legislative Assembly (and its committees and Members) in fulfilling its functions within the institution of Parliament to: make law (and supervise delegated law making), approve and scrutinise the State's finances, scrutinise the actions of executive government (and oversight independent bodies), and provide a forum for debate and grievance
- support Members of the Legislative Assembly in their communication with and representation of constituents
- provide information, corporate and facility management services that better enable Members and parliamentary service officers to achieve their objectives
- safeguard, promote and strengthen the institution of Parliament by improving awareness of the role of the Legislative Assembly, its committees and Members in our democratic system of government and the accessibility of information about parliamentary proceedings and activities.<sup>4</sup>

The Legislative Assembly's activities are coordinated through two main service areas – Members' salaries, entitlements and electorate office services, and parliamentary precinct support services.

The Members' salaries, entitlements and electorate office services area represents the direct cost of Members' salaries and entitlements and maintaining and supporting electorate offices.

The parliamentary precinct support services area provides advisory, information and support services to assist the Parliament, its committees and Members to fulfil their constitutional and parliamentary responsibilities, services to promote the institution of Parliament and raise community awareness and understanding of its important role and functions, and organisational services that support the activities of Members and their staff, and deliver and administer a range of entitlements afforded to Members pursuant to the Members' Remuneration Handbook. The service area also provides services to deliver a safe and secure parliamentary precinct and accommodation and hospitality services that provide Members, staff and guests of the Parliament with an appropriate working environment.<sup>5</sup>

#### 3.1 Budget overview

The Legislative Assembly's operating budget for 2018-19 is \$98.2million, an increase of \$778,000 from the 2017-18 estimated actual. The Service Delivery Statements state that the increase in expenses is mainly associated with employee related costs for enterprise bargaining.<sup>6</sup>

It is proposed that the Legislative Assembly will receive appropriation revenue of \$96.1million in 2018-19, with the remainder of its operating expenses funded from user charges and fees, and interest.<sup>7</sup>

### 3.2 Parliamentary Service capital program

In 2018-19 the Legislative Assembly has a planned capital outlay of \$9.2million. The 2018-19 capital program will focus on:

- completion of a major program to install a fire protection system in Parliament House
- improvements to security surveillance infrastructure within the precinct
- relocation of a number of existing electorate offices arising from the 2017 Electorate Boundary Redistribution and identified risks and deficiencies in some current offices.<sup>8</sup>

### 3.3 Issues raised at the public hearing

Issues raised at the hearing in relation to the Legislative Assembly include:

- Members' participation in the estimates process
- travel expenditure for the Speaker
- the provision of additional staff for non-government or crossbench Members
- procedural matters relating to the estimates process
- planned events and activities to promote the 150<sup>th</sup> anniversary of the Queensland Parliament
- the information technology strategy for the Parliamentary Service
- processes relating to publishing Member information on the website of the Queensland Parliament.

### 3.4 Committee comment
