

Legal Affairs and Community Safety Committee Report No. 46, 56th Parliament

Subordinate legislation tabled between 12 June 2019 and 20 August 2019

1 Aim of this report

This report summarises the committee's findings following its examination of the subordinate legislation within its portfolio areas tabled between 12 June 2019 and 20 August 2019. It reports on any issues identified by the committee relating to the policy to be given effect by the legislation, fundamental legislative principles and lawfulness. It also reports on the compliance of the explanatory notes with the *Legislative Standards Act 1992*.

3 Committee consideration of the subordinate legislation

No significant issues regarding policy, consistency with fundamental legislative principles or the lawfulness of the subordinate legislation were identified.

The committee notes that Mr Lachlan Millar MP gave notice to the House on 22 August 2019 of his intention to move that the Fire and Emergency Services (Levy Groups) Amendment Regulation 2019 be disallowed.

The explanatory notes tabled with the regulations comply with the requirements of section 24 of the *Legislative Standards Act 1992* apart from the explanatory notes discussed below.

4 SL 122 - State Penalties Enforcement (Plumbing and Drainage and Other Matters) Amendment Regulation 2019

4.1 Explanatory notes

Under the heading Consistency with fundamental legislative principles, the explanatory notes state:

The Amendment Regulation has been drafted in accordance with fundamental legislative principles as defined in section 4 of the Legislative Standards Act 1992.

The requirements for explanatory notes set out in Part 4 of the Legislative Standards Act 1992 require explanatory notes to include:

... a brief assessment of the consistency of the legislation with fundamental legislative principles and, if it is inconsistent with fundamental legislative principles, the reasons for the inconsistency.

Arguably, the statement in the explanatory notes only impliedly addresses the issue of consistency with fundamental legislative principles.

The explanatory notes otherwise comply with the requirements in part 4.

5 Recommendation

The committee recommends that the House notes this report.
