#### **Purpose of the Travel**

The primary purpose of this travel was to attend the Commonwealth Parliamentary Association (CPA) Mid-Year Meeting of the Executive Committee in Gibraltar.

The Victorian CPA Regional Representative, Mr Bruce Atkinson, retired at last year's Victorian election and the Victorian Branch indicated they were not in a position to provide a replacement Regional Representative to attend the CPA activities in Gibraltar. Accordingly, Victoria asked if the Standby Branch, being Queensland, would be able to provide an alternate representative and approached my office.

The meeting activities were held between 17-19 April 2023.

The itinerary is enclosed at *Attachment A*.

The full programme for the Mid-Year Meeting is set out in Attachment B.

#### Accompanying persons

Whilst I was the only representative from Queensland participating in the meeting, I was joined by two Australian Regional Representatives, Sen Sue Lines (President, Parliament of Australia) and Hon Mark Shelton MP (Speaker of the House of Assembly, Tasmania).

#### **CPA Executive Committee Overview**

The Constitution of the CPA vests in an Executive Committee the control and management of the activities and business of the Association. The CPA Executive Committee meets just prior to and just after the General Assembly, to which it reports, and the CPA Executive Committee holds a second meeting in another Commonwealth country midway between General Assemblies.

The CPA Executive Committee consists of approximately 36 Members led by the Chairperson of the CPA and comprising the Officers of the Association (who include the Chairperson of the Commonwealth Women Parliamentarians (CWP), the CPA Small Branches Chairperson and the Commonwealth Parliamentarians with Disabilities Chairperson) and three Regional Representatives from each Region, except the CPA Africa Region which, as the largest Region in the Commonwealth, has six Regional Representatives.

The CPA Executive Committee also has two Honorary members - the CPA President and the CPA Vice-President.

#### Benefits obtained from this travel

The benefits of the trip to Gibraltar are set out below:

- Maintain active membership of the Commonwealth Parliamentary Association on behalf of the Queensland Parliament
- Advance Queensland Parliament's interests with the CPA and learn more about areas of mutual interest
- The opportunity to represent Queensland and act as alternate Regional Representative at the Mid-Year Meeting of the Executive Committee as requested by Victoria, with Queensland being the Standby Branch
- The opportunity to contribute to the governance of the Executive Committee
- The ability to develop closer ties with members of the CPA Executive Committee including Officers of the Association and Regional Representatives from each of the nine CPA regions.

#### **Personal Component of Travel**

One day and night was spent in Gibraltar at the conclusion of the meeting programme for personal reasons. Associated costs with the personal component of travel were borne personally.





## Attachment C – APPLICABLE CPA QUEENSLAND BRANCH RULES ON REPORTING OF TRAVEL

## **CPA Queensland Branch Membership, CPA activities and Administrative Guidelines**

#### 3.10 Report to Parliament

Following return from overseas travel, the Member must table in Parliament within one month of return, or the next available sitting, a written report on the overseas travel undertaken.

#### The report is to detail:

- the CPA activity undertaken
- benefits obtained from the overseas travel
- any duties undertaken on behalf of Queensland (which would be ancillary to the primary purpose of the travel)
- the final itinerary or program, including countries visited, dates of travel, and sufficient detail to substantiate the official nature of the journey
- details of accompanying persons (including the spouse) whose costs are to be met by public funds and purpose for their attendance
- details of any personal component of the travel.

All overseas travel for officers will be detailed in the Parliamentary Service annual report.
