To the Electoral Commission of Queensland

Pursuant to s 83(2) of the *Electoral Act 1992*, I, the Honourable Patrick Weir MP, Speaker of the Legislative Assembly

- (i) direct that you proceed according to the law to an election of a Member of the Legislative Assembly of Queensland for the Electoral District of Hinchinbrook;
- (ii) appoint –

Monday, 3 November 2025 to be the day of issue of this Writ;

Friday, 7 November 2025 to be the cut-off day for electoral rolls for the election;

Tuesday, 11 November 2025 to be the cut-off day for the nomination of candidates for the election;

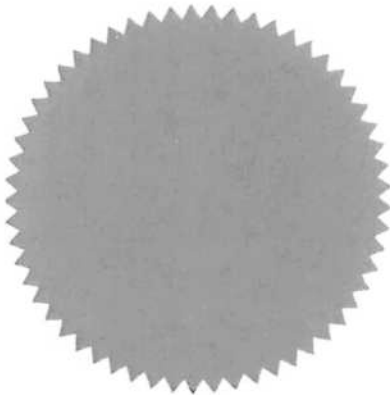
Saturday, 29 November 2025 to be the polling day; and

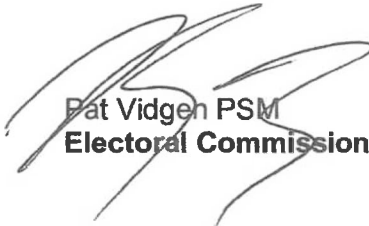
