Erratum to the Explanatory Notes

Title of the Bill

Major Sports Facilities and Other Legislation Amendment Bill 2025

Reasons for the Erratum

This erratum is necessary to ensure the Explanatory Notes accurately describe the effect of the provisions within the Major Sports Facilities and Other Legislation Amendment Bill 2025 (the Bill). The following corrections are required:

- On page 6, Clause 6 incorrectly provides the explanation for Clause 7 of the Bill. Clause 6 of the Bill amends the heading for Part 5, Division 1 of the *Major Events Act 2014* to ‘When major event provisions apply’.
- On page 6, Clause 9 incorrectly states that Clause 9 inserts a new section 30A (Definition for subdivision) into the *Major Events Act 2014*. This amendment did not proceed and is not contained in the Bill as introduced.
- On page 6, consequential renumbering of Clauses 7 and 8 is required to align with the provisions contained in the Bill as introduced.
- On page 7, Clause 10 and Clause 11 incorrectly transpose the amendments to the *Major Events Act 2014* related to the resale of tickets a) in controlled area or major event area and b) at price above original sale price.
- Additionally, Clause 10 describes the omission of section 31(3) of the *Major Events Act 2014*. This amendment did not proceed and is not contained in the Bill as introduced.

The corrections ensure the Explanatory Notes accurately reflect the content and structure of the Bill as introduced to Parliament.

Notes on provisions

Renumbering of explanatory notes

The following explanatory notes require renumbering to accurately reflect the numbering of provisions in the Bill. On page 6 amend the Clause references as follows:

- Clause 7 is renumbered to Clause 8.
- Clause 8 is renumbered to Clause 9.

Clause 6 explanatory note

On page 6, insert a new explanatory note for Clause 6 of the Bill, as follows:

Clause 6 amends the heading for Part 5, Division 1 of the *Major Events Act 2014* to ‘When major event provisions apply’.

Clause 7 explanatory note

On page 6, insert a new explanatory note for Clause 7 of the Bill, as follows:

Clause 7 replaces section 17 with the following:

17 When provisions of this part apply

A provision of this part applies to a major event, a major event area or a controlled area—

- (a) if the provision is prescribed under section 12(2)(d) or (e) or (3)(c) as a provision that applies to the major event, major event area or controlled area; and
- (b) if paragraph (a) applies—for the period for which the provision is prescribed under section 12(2)(d) or (e) or (3)(c) to apply.

Clause 9 explanatory note

On page 6, omit the following incorrect explanatory note for Clause 9:

Clause 9 inserts a new section 30A before section 31:

30A Definition for subdivision

In this subdivision—

original sale price, of a ticket, means—

- (a) the sale price of the ticket when it was bought from—
 - (i) the major event organiser; or
 - (ii) an agent authorised by the major event organiser; and
- (b) a fee or commission charged for the ticket.

Clause 10 and Clause 11 explanatory notes

For ease of reference, this erratum also replaces the entire explanatory notes for Clause 10 and Clause 11.

On page 7, omit and replace Clause 10 with the following explanatory note:

Clause 10 amends section 31 as follows:

- (1) changes the heading of section 31 to ‘Resale of tickets at price above original sale price’
- (2) replaces section 31(1) with the following:

- (1) A person must not sell, or offer for sale, a ticket to a major event at a price greater than 10% above the original sale price of the ticket.

Maximum penalty—

- (a) for an individual—135 penalty units; or
- (b) for a corporation—680 penalty units.

On page 7, omit and replace Clause 11 with the following explanatory note:

Clause 11 inserts a new section 31A as follows:

31A Resale of tickets in controlled area or major event area

- (1) A person must not sell, or offer for sale, a ticket to a major event in controlled area or major event area.
Maximum penalty—
 - (a) for an individual—135 penalty units; or
 - (b) for a corporation—680 penalty units.
- (2) However, subsection (1) does not apply if the person has the written approval of the major event organiser.
