**1 Short title** 3

This Act may be cited as the *Sunshine Coast Waterways Authority Act 2026*. 4

**2 Commencement** 6

This Act commences on a day to be fixed by proclamation. 7

**3 Main purpose of Act** 8

The main purpose of this Act is to establish the Sunshine 9  
Coast Waterways Authority to strategically plan for and 10  
facilitate the sustainable use, management and development 11  
of the Sunshine Coast waterways. 12
