Dear Mr Laurie

Thank you for your letter of 11 February 2010 concerning petition number 1370-10 regarding the proposed skate bowl within the Coastal Reserve situated at Innes Park within the Bundaberg Regional Council Local Government Area.

I can confirm that officers of the Department of Infrastructure and Planning have sought information previously from the Council on this matter. Council had previously contracted a consultancy firm, Ross Planning, to undertake the preparation of an overall management plan for the Innes Park Reserve. The draft management plan was subsequently released for public consultation and at a Council meeting on 24 November 2009, the management plan was adopted.

I have also been advised that Council, at its meeting on 15 December 2009, resolved to proceed with the installation of a skate bowl facility within the Innes Park Reserve, subject to receipt of funding from the Department of Communities' Local Sport and Recreation Program. The petition refers to objection to the project by the Mayor, Councillor Lorraine Pyefinch and Councillor Greg Barnes and this was noted in Council's meeting minutes. A motion to proceed with the project was carried by nine votes to two.

The location of community recreation facilities is a decision for individual Local Governments. Local Governments are charged with taking independent action on a wide range of matters necessary for ensuring the good rule and government of their areas. As such, each Local Government is responsible for how it deals with these matters. In respect of its lawful responsibilities in this case, Council engaged a professional and reputable recreation planning consultant.


There are limited powers available to the State Government or to me, as the Minister for Local Government, to direct Council or to intervene in respect of this matter.
