An Act to change the law relating to succession to the Crown, to validate certain marriages made void by the *Royal Marriages Act 1772* of Great Britain, to repeal that Act so far as it is part of the law of the State and make consequential amendments to other legislation

1	On 28 October 2011, representatives of nations of which Her Majesty is the Sovereign agreed that the rules on succession to, and possession of, the Crown should be changed so as to make succession not depend on gender and to end the disqualification arising from marrying a Roman Catholic.	3 4 5 6 7
2	The United Kingdom has further proposed to disqualify certain persons from succeeding to the Crown as a result of marriage, to repeal the <i>Royal Marriages Act 1772</i> and to validate certain marriages made void by that Act.	8 9 10 11
