**An Act to provide for matters that will benefit residents of communities in the vicinity of large resource projects during their operation, and to amend this Act, the *Anti-Discrimination Act 1991* and the *Mineral Resources Act 1989* for particular purposes**

**The Parliament of Queensland enacts—** 1

**Part 1 Preliminary** 2

**1 Short title** 3

This Act may be cited as the *Strong and Sustainable Resource Communities Act 2016*. 4  
5

**2 Commencement** 6

This Act, other than part 3, division 3, commences on a day to 7  
be fixed by proclamation. 8

**3 Object of Act** 9

(1) The object of this Act is to ensure that residents of 10  
communities in the vicinity of large resource projects benefit 11  
from the operation of the projects. 12

(2) The object is mainly achieved by requiring the owners of, or 13  
proponents for, large resource projects— 14

(a) to prepare a social impact assessment for the projects; 15  
and 16

(b) to employ people from nearby regional communities; 17  
and 18

(c) not to discriminate against residents from nearby 19  
regional communities when employing for the projects. 20

**4 Act binds all persons** 21

(1) This Act binds all persons, including the State. 22

(2) However, nothing in this Act makes the State liable to be 23  
prosecuted for an offence. 24

- (2) The owner or proponent must, as part of the EIS for the project, prepare a social impact assessment that—
- (a) provides for the matters mentioned in subsection (3); and
- (b) includes the matters stated in the guideline made under subsection (4).
- (3) The social impact assessment must provide for the following in relation to the project—
- (a) community and stakeholder engagement;
- (b) workforce management;
- (c) housing and accommodation;
- (d) local business and industry procurement;
- (e) health and community well-being.
- (4) For the matters mentioned in subsection (3), the Coordinator-General may make a guideline stating the details that must be included in a social impact assessment and publish the guideline on the department’s website.
- (5) In preparing the social impact assessment under subsection (2), the owner or proponent must consult with the local government for the local government area in which the large resource project is situated.
