### **2 Appropriation for 2016–2017**

(1) The Treasurer is authorised to pay \$87,384,000 from the consolidated fund for the Legislative Assembly and parliamentary service for the financial year starting 1 July 2016.

(2) The amount mentioned in subsection (1) is appropriated for the financial year for the Legislative Assembly and parliamentary service for application to its departmental services, equity adjustment and administered items as stated in schedule 1.

(3) The amount mentioned in subsection (1) includes the amount already authorised by the *Appropriation (Parliament) Act 2015*, section 3, to be paid for the financial year starting 1 July 2016.
