4.0 Executive Summary

The purpose of the visit to the United Kingdom (UK) and Spain was to establish cooperative relationships with senior executives across the global renewable energy industry. As decarbonisation strategies are delivered across the globe, in a competitive industry, these relationships will be vital to ensure Queensland transitions to a renewable state.

The engagements that occurred with key contacts in the UK and Spain will assist the Queensland Government to better serve Queenslanders, having observed and discussed best practice across topical areas of the portfolio and established relationships for Queensland to underpin future collaboration.

The objectives were to:

- Energy Workforce: commence a campaign to attract skilled energy workers
 from the UK to come to Queensland to help build the SuperGrid, an approach
 that is supported by all key stakeholders in the energy industry. In addition,
 gain an understanding of future workforce training approaches by visiting the
 state-of-the-art transmission worker training facility operated by Iberdrola in
 Madrid:
- Energy Investment: meet with key existing British and European investors and potential new investors in energy projects in Queensland to highlight opportunities from the Queensland Energy and Jobs Plan. In addition, meet with key government officials around best practice in the energy transformation:
- Hydrogen: gain an understanding from European stakeholders on the opportunity of hydrogen and its uses;
- Pumped Hydro: inspect a large scale pumped hydro in Spain and discuss learnings from its construction with operators;
- Local Manufacturing: visit manufacturing facilities in the renewable energy supply chain to identify opportunities and barriers to developing such capability in Queensland.

The visit met its objectives and laid the foundations for ongoing engagement with renewable energy companies in Europe and the UK.

The visit also provided confirmation that Queensland is one of the most attractive opportunities for renewable investment in the world.

A common theme from the engagements is that Queensland has the most desirable natural assets, public infrastructure, and clear transition pathway to renewables. Backed by public ownership, Queensland is well placed to deliver on the Queensland Energy and Jobs Plan.

5.0 Mission Overview

5.1 Dinner with Trade and Investment Queensland and Australian High Commission – Sunday 3 September 2023 – London, England

The dinner, hosted by Trade and Investment Queensland (TIQ) provided an opportunity to be briefed by Ms Elisabeth Bowes, Deputy Head of Mission, United Kingdom on the recent Royal Assent of the Australia-United Kingdom Free Trade Agreement (UK FTA). The Australia-UK FTA is a historic agreement representing the UK's first new trade deal signed since Brexit.

Topics of discussion included how the UK FTA will provide benefit, with additional access to the agriculture industry, create more jobs, remove unnecessary barries to trade between the UK and Australia, and open new industries for world class importing and exporting.

5.2 Meeting with RWE - Monday 4 September 2023 - London, England

RWE is one of the largest energy utilities in the world and is progressing strategies towards decarbonisation. Having entered the Australian market in 2018, RWE is focused on expanding its renewable portfolio within Queensland and sees an opportunity to be a key driver of Queensland's energy transition, with a strong focus on community and industry partnership.

RWE are looking to boost their onshore solar and batteries presence in Queensland. RWE discussed current grid infrastructure, and acknowledged the extensive work Government Owned Corporation (GOC), Powerlink has already done in ensuring there is a pathway which indicates how the grid will be ready to accommodate the renewable transition. RWE acknowledged the work that the Queensland Government has done, particularly in the last two years, and how they have had continued positive interactions with GOC's Stanwell and Powerlink.

RWE advised the Queensland delegation that the attractiveness of Queensland is due to public ownership, support from the Government, the size and scalability, and the abundance of solar. RWE expressed a desire to be "reliable player" and "preferred partner" in Queensland, with a vision to having a long-term physical presence in the state.

A key learning from the engagement was the strong commitment RWE have to delivering community associated benefits, such as local manufacturing and local jobs. RWE acknowledged that every community is different and will require tailored community consideration.

RWE briefed the delegation on their experience through Europe, and what learnings could be applied to projects in Queensland.

RWE also expressed their commitment to exploring innovative ways to manage end of life components, such as repowering methods like taking down wind turbines and rebuilding, which may also result in doubling production with less turbines where possible.

The Minister briefed RWE on the Queensland Government's strong commitment to the renewable transition, social licence and the Queensland Energy and Jobs Plan.

RWE commented that Queensland has the best natural assets and infrastructure to be a world leader in Hydrogen. The Queensland delegation made a commitment to share relevant infromation with RWE.

RWE committed to providing further information on the lessons they have learnt from other European projects, how they could deliver agrivoltaics in Queensland, how they would position themselves in Queensland, management of end-of-life components, and how a training academy approach could provide a pathway to a future energy workforce for Queenslanders.

The Queensland delegation committed to continuing conversations with other government agencies on the recycling of renewable energy components, such as Department of Transport and Main Roads and Department of Environment and Science.

5.3 Meeting with Parliamentary Under Secretary of State (Minister for Energy Efficiency and Green Finance) – Monday 4 September 2023 – London, England

In March 2023, the UK Government released the Powering Up Britain: Energy Security Plan which sets out steps the Government is taking to ensure the UK is more energy independent, secure and resilient. Renewable generation in the UK reached a record share of 47.8% of total generation in Q1 2023. The Minister and Under Secretary of State discussed the UK's transition to renewable energy, ambition to pursue a hydrogen industry, household smart metre uptake, and upcoming energy efficiency reforms in the UK.

There were shared learnings on how both governments have implemented energy efficiency changes, with the UK Government trying to mitigate their strong reliance on gas, which powers 80% of space heating. Discussions on industry's response to changes, associated benefits, impact on housing stock (both private and social) and similarities to the National Construction Code 2022 being implemented in Australia occurred.

Lord Martin Callanan briefed the Queensland delegation on the high increase in solar uptake in the UK and the Government's decision to enforce firm targets for smart metre uptake. Lord Callanan shared lessons the UK Government had learnt from enforcing these measures, and what challenges were encountered.

The UK representation committed to providing a key contact for policy officers in Queensland's, Department of Energy and Public Works to discuss further similarities and gain a shared understanding of the path to energy efficiency.

The networking lunch in London was attended by European investors considering locating and investing in Queensland. The Minister provided a presentation on the Queensland Government's commitment to renewable energy, the Queensland Energy and Jobs Plan, and provided certainty that Queensland has a clear pathway in its transition to renewables. The Director-General also provided a presentation, which focused on Queensland's SuperGrid Infrastructure Blueprint and the forecast transformation of Queensland's generation mix, which will include more wind, solar and energy storage.



5.5 Meeting with Mott MacDonald – Monday 4 September 2023 – London, England

Mott MacDonald is a global engineering, management and development consultancy firm who support a range of renewable energy projects. Mott MacDonald provides social performance advisory services to help organisations to avoid and manage project risks, respect human rights, share project benefits more equitably, and empower affected people.

The discussion with Mott MacDonald focused on social licence, and approaches taken in the UK on large scale projects. Mott MacDonald briefed the delegation on recent learnings from High Speed 2, which is a planned high-speed railway line connecting the south (London) to the north of England (Manchester). The project will impact a number of communities and large sections of land will be acquired to allow for this infrastructure to be developed.

Mott MacDonald briefed the Queensland delegation on what considerations should be made prior to considering a proposal of this size and how a project could be positioned to ensure all communities are confident that they are benefiting.

Mott MacDonald shared their views on the importance of transparency with affected communities, the need for a strong public facing engagement campaign and the need for legacy transition planning.

Mott MacDonald informed the delegation on an innovative digital platform they have used on projects as a key tool for engagement. Mott MacDonald committed to sharing an example of this platform with the delegation.

Key learnings for the Queensland Government on this visit was the need for a central contact point in a project that manages community engagement, the need for transparency with communities, the need to plan for a legacy, and the need to ask the community how and when they want to be communicated with.

5.9 Meeting with Minister of State (Cabinet Office) – Tuesday 5 September 2023 – London, England

In 2022, the UK Procurement Bill (the Bill) was introduced into the UK Parliament, aiming to establish a single legal framework for the award of public contracts, utilities contracts, concession contracts and defence and security contracts by contracting authorities. The new framework maintains the European Union principles of transparency, equal treatment, and non-discrimination. However, the Bill proposes new objectives which must be applied by contracting authorities – value for money, maximising public benefit and integrity.

The meeting with Baroness Neville-Rolfe DBE CMG, Minister of State and the Queensland delegation was an opportunity to share the approaches both jurisdictions have taken to procurement. The Baroness advised the delegation of the significant challenges faced with the Bill, noting that UK procurement is valued at \$300 billion, 14% of GDP. The Baroness also shared the requirements for contracts to be published online, as well Key Performance Indicators (KPIs) for contracts valued at over \$5 million.

The Minister was able to inform the Baroness on Queensland's position, including the Procurement Policy and supporting measures such as the Ethical Supplier Mandate.

5.12 Tour of Iberdrola Training Campus – Wednesday 6 September 2023 – Madrid, Spain

The Iberdrola Campus for Innovation and Training was opened in April 2021. The facility is used as a test hub to accelerate the energy transition and has enabled over 13,000 people to receive training at the facility each year. The campus provides training in areas such as, underground power installation, overhead transmission and distribution and wind technology. The campus represents Iberdrola's commitment to technology, research and development and collaboration with technology centres as levers for leading the energy transition, the green recovery of the economy and employment, improving the employability of young people and senior professionals in future sectors.

Each Iberdrola employee receives a compulsory, 53 hours of training per year, in the form of classes and workshops at the training facility, as a well as training activities held in collaboration with universities.

A key action out of the Queensland Energy and Jobs Plan and the Queensland Workforce Strategy is the development of a Future Energy Workforce Roadmap in 2023 that will identify opportunities to build and develop workforce capacity and capability, while ensuring Queensland has the right training in place, in the right locations to provide regional workers with more opportunities to secure jobs in the energy sector.

This site tour provided the Queensland delegation with the opportunity to view this innovative, state-of-the-art training facility and consider how some of these practices could be applied in Queensland.


Iberdrola committed to sharing with the Queensland Government their software, which is used to simulate real world scenarios and assist training the future renewable energy workforce.

5.14 Meeting with Australian Ambassador to Spain – Thursday 7 September 2023 – Madrid, Spain

The Australian Ambassador to Spain, HE Sophia McIntyre briefed the Queensland delegation on the current renewable energy industry, and the substantial investment Spanish organisations are making in the energy sector. Like Australia, Spain has similar natural resources with an abundance of solar and wind.

The Ambassador acknowledged the ambitious Queensland Energy and Jobs Plan, and believes the Queensland Government's plan is one of the best planned transitions to renewables.

The Ambassador advised the Queensland delegation that Spain are planning to phase out some electricity sources, like nuclear, by 2035.

The Ambassador also shared that the transition from gas to renewables will be difficult for Spain, with one third of consumers still using gas.

A discussion occurred regarding electric vehicle (EV) uptake and charging infrastructure in Spain. The Ambassador commented that Spain was now the second largest manufacture of cars in Europe and are experiencing a high uptake of EVs. With that increase, meticulous planning is required to ensure the transmission network can meet the predicted electricity demand.

5.15 Meeting with Iberdrola Networks – Thursday 7 September 2023 – Madrid, Spain

Iberdrola is a global leader in clean energy, grids and storage, supplying energy to almost 100 million people worldwide and employing more than 38,000 people. Iberdrola has been committed to clean energy for more then 20 years, with the objective of exceeding 52,000 MW of renewable capacity by 2025.

The meeting with Iberdrola was an opportunity for the Queensland delegation to seek from Iberdrola their views on Queensland's transition, and as a major renewable energy company, what would they be wanting to see from Queensland.

The main feedback from Iberdrola was that they require certainty around the transmission, in particularly connection and grid readiness. Iberdrola advised the Queensland delegation that transmission is key in the transition to renewables being successful. Grid readiness will also support the uptake of EVs due to more public EV charger installations. Iberdrola noted that it was extremely beneficial that distribution and transmission is publicly owned.

Iberdrola provided their vision to build larger projects that exceed current demand, to ensure they are future proofed for years to come.

Iberdrola agreed that hydrogen was best only used when electrification wasn't possible, i.e for heavy vehicles and machinery, and should not replace renewable sources such as wind and solar. Iberdrola also agreed that Asia would be the best market for hydrogen exporting, given their lack of natural resources.

Iberdrola share the Queensland Government position that securing social licence is critical. Iberdrola provided suggestions on how social licence could be secured and suggested that research should be done to tailor each project to gain community acceptance.

Iberdrola believe there is a huge opportunity in Queensland with the energy transition. Iberdrola commented that there is a clear, and transparent pathway, backed by public ownership which makes Queensland one of the most desirable investment opportunities.

5.17 Tour Power Electronics HQ and production facility – Friday 8 September 2023 – Valencia, Spain

Power Electronics is a world leader in the manufacturing of solar inverters and energy storage. The company is currently finalised a project to develop the largest battery self-consumption project in Spain, installed on the facility's own rooftop.

Queensland has the highest rate of household rooftop solar installations in Australia. To store this abundant rooftop solar, the Queensland Government is developing a new Queensland Battery Industry Strategy. The strategy is focused on growing Queensland's role in the battery supply chain. To start delivering battery storage needed now, the Government is investing in more large-scale and community batteries to store excess rooftop solar.

A tour of Power Electronics provided the delegation with an opportunity to view state-of-the art advanced manufacturing. The delegation had the opportunity to view solar inverters being constructed, batteries and EV chargers.

The delegation gained an understanding of the size, technical skills and technology required to have local advanced manufacturing in Queensland.

5.18 Site visit Iberdrola La Muela II 2GW Hydropower plant – Friday 8 September 2023 – Valencia, Spain

Iberdrola commenced construction of the first phase of La Muela hydroelectric power complex in 1983. In 2015, the complex was expanded with the construction of the La Muela II plant. The 1.8GW hydropower complex comprises the 290MW Cortes II conventional hydroelectric plant, the 634MW La Muela I and the 878MW La Muela II pumped hydro storage power plants.

With the commissioning of the La Muela II pumped storage hydroelectric facility expansion in October 2013, the site is capable of producing over 1.7GW of electricity a year, which is enough to meet the annual power demand of approximately 400,000 households. Iberdrola advised that they are forecast to generate a record supply over the next year, due to increases in demand.

The Queensland Government has committed to investigating the 2GW 24-hour Borumba and the 5GW 24-hour Pioneer-Burdekin Pumped Hydro energy storage projects (PHES).

The visit of Iberdrola's La Muela site provided the Queensland delegation with the opportunity to ask technical questions about the project, such as choice of manufactures, type of turbines used and issues that occurred during the build.

Iberdrola also shared lessons they learnt and changes that they have implemented into their latest PHES project under construction in Portugal.

The Queensland delegation gained an understanding of the scale of the project and considerations that should be applied to Borumba and Pioneer-Burdekin.

The visit also allowed for discussions on future renewable development opportunities that Iberdrola are considering.


