I refer to petition 4336-25, tabled in the Legislative Assembly on 9 December 2025. I note the petitioners concerns regarding renewable energy in Queensland.

The Crisafulli Government is committed to delivering affordable, reliable and sustainable energy for all Queenslanders. The recently released Energy Roadmap delivers upon this, improving the assets we have while building what is needed for the future, which is placing downward pressure on prices, boosting private sector investment into new generation, and easing pressure on the State's balance sheet.


As reported by the Clean Energy Council, this investment is already occurring, with Queensland having over 4.2 gigawatts (GW) of renewable electricity projects under construction or financially committed - more than any other state in the country. Queenslanders also continue their enthusiastic adoption of renewable energy by investing in residential and commercial solar systems at record levels. That adoption is being further supported through the Crisafulli Government's Solar for Renters program, which is delivering real cost of living relief for Queenslanders. This is a program that was ended by the former Labor Government. However, our government has restored it – easing costs for renters, enhancing property values and supporting renewable energy adoption in Queensland.

The Energy Roadmap also promotes new investment into our energy system through the \$400 million Queensland Energy Investment Fund, and Queensland Investment Corporation's new Investor Gateway to drive private sector investment into new energy generation and firming projects.

The Queensland Government is also committed to the Priority Transmission Investment framework and Regional Energy Hubs to progress critical transmission infrastructure in an efficient and effective manner. Early strategic works across the network will be undertaken to retain flexibility while ensuring timely transmission infrastructure delivery. In the short term, this will include supporting industrial loads in north and central Queensland to source affordable, reliable and sustainable energy.

I thank the petitioners for taking the time to raise their concerns with the government, and I trust this information is of assistance.
