Election of Chairman:

The Research Director opened the meeting, advising that the Legislative Assembly had established the Parliamentary Committee for Electoral and Administrative Review of the 47th Parliament by resolution on 10 November 1992. The resolution provided that the membership of the Committee be Dr Clark, Mr FitzGerald, Ms Power, Messrs Quinn, Rowell, Sullivan and Welford.

As Standing Order 190 prescribes that before proceeding to any other business the Committee shall elect its Chairman, Mr FitzGerald as the longest serving Member present, was invited to call on the voice of the Members present for the nomination of the Chairman. Agreed to meet on Friday 13 November 1992 from 12.30 pm to 2.30 pm for the principal purpose of interviewing applicants for the Research Director's position.
