An Act authorising the Treasurer to pay amounts from the consolidated fund for departments for the financial years starting 1 July 2013 and 1 July 2014

The Parliament of Queensland enacts—

1 Short title

This Act may be cited as the *Appropriation Act 2013*.

Note—

Under the *Financial Accountability Act 2009*, section 5, words used in this Act that are defined under the *Financial Accountability Act 2009* have the same meaning the words have in that Act, subject to a contrary intention in this Act.

2 Appropriation for 2013–2014

- (1) The Treasurer is authorised to pay \$47 369 432 000 from the consolidated fund for departments as itemised in schedule 1 for the financial year starting 1 July 2013.
- (2) For each department, the vote amount mentioned for the department in schedule 2 is appropriated for the financial year for the department for application to its departmental services, equity adjustment and administered items as stated in schedule 2.
- (3) The amount mentioned in subsection (1) includes the amount already authorised by the *Appropriation Act 2012*, section 3, to be paid for the financial year starting 1 July 2013.

3 Supply for 2014–2015

The Treasurer is authorised to pay \$23 684 716 000 from the consolidated fund for departments for the financial year starting 1 July 2014.

4 Repeals

The following Acts are repealed—

- Appropriation Act 2010, No. 28
- Appropriation Act 2011, No. 23.
