REPORT TO THE LEGISLATIVE ASSEMBLY

1 Estimates Committee A presents its Report to the Legislative Assembly in relation to the estimates of expenditure for the Legislative Assembly (Parliamentary Service Commission).

Introduction

- 2 The Legislative Assembly on 31 March 1995 appointed six Estimates Committees to inquire into the estimates of expenditure contained in the *Appropriation (Parliament) Bill* 1995 and the *Appropriation Bill 1995*.
- 3 This Committee, under the Sessional Orders adopted by the House, has had the following organisational units allocated to it:

Office of the Governor;

Legislative Assembly (Parliamentary Service Commission);

Queensland Audit Office;

Parliamentary Commissioner for Administrative Investigations;

other organisational units within the portfolio of the Premier and Minister for Economic and Trade Development;

other organisational units within the portfolio of the Treasurer, and

other organisational units within the portfolio of the Minister for Housing, Local Government and Planning and Minister for Rural Communities.

- 4 The Sessional Orders also require that Estimates Committee A present two Reports, one for the Legislative Assembly and another for the Office of the Governor, the Queensland Audit Office, the Parliamentary Commissioner for Administrative Investigations, and other organisational units within the portfolio of the Premier and Minister for Economic and Trade Development, organisational units within the portfolio of the Treasurer and organisational units within the portfolio of the Minister for Housing, Local Government and Planning and Minister for Rural Communities.
- 5 Estimates Committee A has now considered the estimates referred to it in relation to the Legislative Assembly (Parliamentary Service Commission) and has met in public session to receive evidence from the Speaker of the Legislative Assembly and officers of the Parliamentary Service. Additional information, which has been received as a result of questions asked during the public session, will be presented to the House separately in an additional volume of information.

Estimates for the Legislative Assembly

6 Apart from identifying future directions and priorities through its revised strategic plan, the Service has implemented operational plans in its various offices to ensure improved accountability and efficiency in the use of resources. In evidence, the Speaker informed the Committee that as part of the ongoing aim of improvement, six sub-programs are presently being reviewed and that significant changes are expected as a result of these evaluations.

- 7 One of the innovations brought to the attention of the Committee was the negotiation of a revenue retention agreement with Treasury. When questioned as to sources of the retained revenue, the Speaker informed the Committee that it flowed from the sale of goods and services in the coming twelve months. In particular, the sales of publications and the revenue received from seminar activities conducted by the Education Office made some contribution. However, the principal source of revenue comes from Hansard as a result of the contracting out of reporting services to the State Reporting Bureau. The Committee understands that there are ancillary benefits in this practice in that it allows the maintenance of reporters' skills when the House in out of session while at the same time providing a small, but valuable revenue source. It is also understood that the retention of revenue from the recently opened Parliament House Gift Shop is currently being negotiated with Treasury. The Committee is firmly of the opinion that such revenue should be retained.
- 8 The Committee's questioning of witnesses also revealed an increasing move towards the use of technology to effect savings while improving services. The Committee is satisfied that the enhanced use of technology has reduced the production cost of many publications. In addition to this, the Committee looks forward to the time when Members, staff and other clients are also able to electronically select the information or documents they require. It is understood that, to enhance this, plans are in hand to determine whether advantages exist in being able to utilise the data available through the Internet system.
- 9 Allied to these changes in the use of technology are proposals to increase the electronic access to Hansard by clients. The Committee was told that it was hoped that Hansards from 1990 would be able to be made available on CD-ROM. This would result in a production cost some 15% of that involved in producing bound volumes. While evidence was not given, it is assumed that through the use of electronic media other benefits accrue, including enhanced search and retrieval capabilities.
- 10 The Committee has also noted the decreasing price of Hansard over recent years. While in 1988 the cost per page of Hansard was \$156 this has now fallen to \$35 for the Weekly Hansard and \$16 for the Daily Hansard. At the same time, publication times have reduced. This, together with the proposal to also produce Hansard on CD-ROM, will ultimately make it more freely available and at lower cost. The Committee believes that this access to Hansard is essential to better assist the community in becoming aware of the activities, decisions and debates of their elected representatives.
- 11 Questioning by the Committee also revealed other steps being taken to better apply available funds. Some Members of the Committee were concerned that a move towards more flexible staffing arrangements in the Parliamentary Library could result in the employment of people who did not know its system and that this could decrease its efficiency. The Committee was assured by the Speaker that a review presently being undertaken was to ensure that the resources resident in the Library were being utilised to maximum efficiency. As a further indication of the support for the Library, the Speaker informed the Committee that while large cutbacks had occurred in discretionary expenditure, the Library had continued to be funded at an improved rate. He also indicated to the Committee that the Library staff establishment was 32, including 11 in

its research section, seven in the publication and resources section, nine in the information management section and three in the information systems section.

- The Committee also sought information on the extent of use of the Education Office by 12 Members and details of the services it provided to schools. The Committee was informed that the services provided by the office are divided into three areas, namely educational information services, educational programs and protocol services. Furthermore the production of multimedia resources is a major ongoing function of the office. In the financial year 1994-95, the office processed over 300 enquiries relating to information on the processes and practices of the Parliament. This resulted in several thousand items of print materials being distributed to clients. The Committee was also told that in the financial year 1994-95 approximately 27,500 students will tour Queensland Parliament. The majority of these students come from primary and junior secondary schools. In the financial year 1994-95 the Education Office also helped develop a small parliamentary education facility at Barcaldine and it is planned to expand this facility in the financial year 1995-96. The Education and Protocol Office also conducts education programs for public servants, new Members of Parliament and parliamentary service staff. In the financial year 1994-95, 17 seminars were conducted for public service groups from individual government departments on selected parliamentary practices and processes.
- 13 In relation to underexpenditure of funds for the Committee system, the Speaker explained that this was attributable to the proposed new system not yet being in place. It was pointed out, however, that the necessary legislation had been introduced and that it was listed for debate. Expenditure in relation to this item could, therefore, be anticipated in the coming financial year.
- 14 The Committee believes that all Members are concerned that the level of equipment available to them is sufficient to allow them to properly discharge their functions and duties to their electors. This concern resulted in a series of questions about accommodation, levels of equipment and secretarial support. The Committee was told that in the financial year 1994-95, 12 Members were relocated to more appropriate office accommodation to deal with problems of space, access, security and expired tenancies. In addition, an allocation of funds had been made for new computer equipment and action to acquire the equipment was well advanced.
- 15 The Committee also sought information as to whether any provision had been made for additional support for those Members who represented large electorates. The Committee was informed that the Parliamentary Service Commission had previously decided that the matter would not be dealt with during the current Parliament.
- 16 Finally, questions were also raised about the use of consultants by the Parliamentary Service. It was explained that these fall into different categories. First, were the provisions made by Parliamentary Committees to employ consultants to provide specialist advice in relation to complex matters which could arise during the course of investigations. Second, information technology consultants were employed, through the Information Policy Board, to provide advice on current trends in software and hardware development and to advise on future strategies to take advantage of the rapidly changing services and products available. Third, external and internal audits of the Service's accounts are required by the *Financial Administration and Audit Act* and these fall into the category of consultants. Finally, the processing changes paid to CITEC for use of the Queensland Government Financial Management System also fall into this category. It

is this system which maintains accounts payable, and the general ledger and assets systems.

General Comments

- 17 This is now the second year in which the appropriation for the Parliament has been contained in a separate Bill. This important step in ensuring the separation and independence of the Parliament from the Executive was originally recommended by the Electoral and Administrative Review Commission. It is important that this separation of Parliament from the Executive continues to be recognised and, wherever practicable, to be sought.
- 18 In this respect, the Committee notes that the Speaker indicated that the Budget put forward to the Treasury by the Parliamentary Service Commission, with some changes, is that which is now contained in the *Appropriation (Parliament) Bill*. The Committee believes that the Parliament's independence and administration of its own affairs should be strengthened at every possible opportunity so that no perceptions can arise which may detract from its purpose and functions.

The Estimates Committee Procedure

- 19 This is now the second year of Estimates Committee hearings and it is appropriate that the Committee pass some comment on the processes and procedures adopted by the House for the conduct of the Committees.
- 20 With any new system, there will be areas which can be improved to better produce the intended final result. With Estimates Committees, that result is a thorough examination of the estimates of expenditure of the Executive Government, and a justification of its allocation of funds and performance in delivering appropriate outcomes.
- 21 While this year the level of familiarity with the system and its requirements resulted in a greater level of confidence, there is still a need for certain aspects to be reviewed. This was discussed by the Committee and was also the subject of questioning during the Committee's public hearing. It cannot be too highly stressed that the proper scrutiny and accountability of the Executive area of government is an essential part of the democratic process. It is also obvious to the Committee that the Estimates process results not only in greater public accountability but also forces departments to regularly examine their internal operations and assess their own performance. It is also clear that ultimately all stakeholders, including Departments, Ministers, Members of Parliament and the public, benefit from the process.
- 22 The Committee believes that the time is now right to further consider undertaking a review of the system to ensure that the greatest possible benefits can be achieved from it. In evidence to the Committee it was suggested that this could be carried out by the Parliament and this suggestion is supported by some Members of the Committee as being the most appropriate approach.
- 23 In performing a review there are many areas which should be examined. First, the timetabling of the hearings imposes unnecessary time constraints which impact on the different committees in different ways. For Estimates Committee A there is little time to prepare for hearings into what are major policy areas of the Government. In contrast to this, Estimates Committee F has far greater time to prepare, but limited time in which it

can consider its findings. The problems thus created are exacerbated by holding each committee's hearings on only one day, limiting the depth of questioning able to be carried out. It has been suggested by some Members that this could be overcome by having committees hold public hearings over two days and by having concurrent sittings of two committees.

- During meetings of this Committee it has also been proposed that a more structured approach could be achieved by undertaking questioning on a program basis. However, it is not possible to do this effectively within the constraints imposed by the existing time limits without limiting, for some Members, the extent of questioning they wish to pursue on certain areas. For example, a move from one program to another partway through a 20 minute time allocation is immediately thwarted if, in the next time period, it is necessary to go back to complete a previous line of questioning. The relative advantages of the two systems needs to be considered to maximise the effectiveness of the estimates process.
- 25 Some Members also believe that the scope of allowable questioning needs more precise definition and that a proper examination of the Budget should extend beyond proposed expenditures to include the revenue which will finance them. This matter is one which could also be included in any review carried out. Similarly, while it is agreed that the documentation supplied is an improvement over the previous year, it is felt by some individual Members that greater detail at sub-program level should be included and that the inclusion of outcomes as well as outputs would provide a basis for more realistic evaluations of program effectiveness.

Conclusion

- 26 The Committee appreciates the co-operation afforded to it by the Honourable the Speaker and members of the Parliamentary Service. The Committee thanks these officials on their preparedness and willingness to provide the Committee with full and frank responses to its questions, thereby providing proper accountability to the Parliament.
- 27 The Committee has agreed to the proposed expenditures referred to it, without amendment.

Recommendation

28 The Committee recommends that the proposed expenditure be agreed to.
