

ESTIMATES COMMITTEE C

REPORT NO. 1 OF 2001

1. INTRODUCTION

The sessional orders adopted by the Legislative Assembly on 30 May 2001 established estimates committees to examine and report on the proposed expenditures stated in the *Appropriation Bill 2001* and the *Appropriation (Parliament) Bill 2001*. The orders require Estimates Committee C to examine the proposed expenditure for the portfolios of:

- the Minister for Transport and Minister for Main Roads;
- the Minister for Innovation and Information Economy; and
- the Minister for Public Works and Minister for Housing.

The committee has considered the estimates for these portfolios by examining the budget papers, ministerial portfolio statements and other information provided by the ministers and their advisors.

This report highlights the proposed expenditures the committee examined and makes a recommendation to the Parliament. A separate volume tabled with the report contains the minutes of the committee's meetings, the committee's questions taken on notice by ministers prior to and during a public hearing on 12 July 2001 and the answers to these questions and supplementary information the ministers provided.

2. TRANSPORT AND MAIN ROADS PORTFOLIO

The Transport and Main Roads Portfolio comprises the Department of Transport (Queensland Transport), the Department of Main Roads and government-owned corporations (GOCs), statutory authorities and other units that report to the minister through these departments.

The total appropriations provided to these departments in the *Appropriations Bill 2001* is \$2.96 billion as follows:

2.1 DEPARTMENT OF TRANSPORT

Queensland Transport is the lead agency responsible for developing and managing the land, air and sea transport environments in Queensland. Queensland Transport has a *leadership* role in transport policy and planing, a *stewardship* role in managing the use and access to the transport system, and a *service delivery* role in providing coordinated and integrated transport-related services and infrastructure.

The GOCs and statutory authorities that answer to the minister through the department are:

2.2 DEPARTMENT OF MAIN ROADS

The Queensland Department of Main Roads manages the State-controlled road network on behalf of the State Government. Queensland's 34,000 kilometres of State-controlled road network represents 20 percent of Queensland's road network and carries 80 percent of the state's traffic. The department also owns Queensland Motorway Limited.

- provisions in the budget for the erection of sound barriers on the Pacific Motorway;
- the 10 percent increase in the debt to equity ratio for commercial operations;
- comparative 2001-02 and 2000-01 road funding;

- impact on the Commonwealth *Roads to Recovery* program on State road funding;
- roads expenditure in 2001-02 outside south east Oueensland:
- the Nundah Bypass project;
- delivery of the Roads Implementation Project in regional areas during 2000-01;
- the Federal Government's Blackspot Funding Program;
- the Tugun Bypass project;
- the Port of Brisbane Motorway; and
- the Outback Highway (Reef to Rock) concept.

3. INNOVATION & INFORMATION ECONOMY PORTFOLIO

The Innovation and Information Economy portfolio seeks to identify Queensland's key strengths in innovation and emerging technologies and enable government, industry and the community to take advantage of opportunities in the new knowledge economy¹. It comprises part of the Department of Innovation and Information Economy, Sport and Recreation Queensland (DIIESRQ) and includes CITEC.

CITEC operates as a fully commercial business, and plays a significant role in improving employment opportunities in the information technology and telecommunications industry and in improving access to government information and services throughout Queensland.

3.1 DEPARTMENT OF INNOVATION AND INFORMATION ECONOMY, SPORT AND RECREATION QUEENSLAND

The Government created the Department of Innovation and Information Economy, Sport and Recreation Queensland on 22 February 2001. It comprises: the Government's Information Technology and Telecommunications (IT&T) industry development functions; *Access Queensland*, the Government's integrated service delivery initiative; and policy and strategic coordination functions.

Under the Government's Administrative Arrangements, the department is accountable to both the Deputy Premier, Treasurer and Minister for Sport and the Minister for Innovation and Information Economy in relation to the administration of their respective portfolios. The Director-General and the Internal Audit and Corporate and Executive Services areas of DIIESRQ support both portfolios.

The total appropriation provided to the department in the *Appropriations Bill 2001* is \$180.39 million. The apportionment of the appropriation across the Innovation and Information Economy (IIE) and Sport and Recreation Queensland (SRQ) areas of the agency is as follows:

- Information Industry Bureau (IIB) services to regional clients;
- benefits from investment in biotechnology;

4. PUBLIC WORKS AND HOUSING PORTFOLIO

The Public Works and Housing Portfolio comprises the Department of Public Works, the Department of Housing and statutory authorities that report to the minister through these departments.

The total appropriations provided to these departments in the *Appropriations Bill 2001* is \$434.138 million as follows:

4.1 DEPARTMENT OF PUBLIC WORKS

The Department of Public Works aims to assist Queensland Government agencies in identifying and accessing appropriate infrastructure and services to progress Government priorities and assist agencies in the achievement of their goals and objectives.

The department achieves this by: providing leadership in the delivery of the Government's Capital Works Building Program in partnership with industry; undertaking a lead agency role in procurement policy and practices for the whole-of-Government; providing a range of value for money services; providing advice and support to Government agencies to assist them in identifying, procuring and managing their individual infrastructure needs; and providing leadership advice and support to, and development of, the Queensland Building Industry.

The statutory authorities that answer to the minister through the department are:

- Board of Professional Engineers of Queensland
- Board of Architects of Queensland.

The department's projected outputs and costs for 2001-2002 are as follows:

- construction of the Cairns Government Office Building;
- implementation of the State Purchasing Policy;
- Q Build's operational management responsibility for the Roma Street Parkland:
- fleet trial of hybrid vehicle technology;
- employment of apprentices, trainees and graduates;
- measures by the Building Services Authority to reduce unlicensed building contracting; and
- the Backflow Prevention project.

4.2 DEPARTMENT OF HOUSING

The Department of Housing plays an important role in providing direct and indirect housing assistance and in influencing the overall housing system within Queensland.

Taking a responsive, integrated and flexible service approach in developing solutions for un-met housing needs, the Department focuses on assisting clients to achieve successful housing outcomes which contribute to individual, family and community sustainability. The Department is committed to working in partnership with other government agencies, industry, community and the private sector to help individuals, particularly the most vulnerable, to find appropriate housing solutions.

- Queensland Building Services Authority.

- expenditure incurred by the Director-General;
- funding to assist the Graceville Centre in Nambour;
- provisions to fund crisis accommodation in the electorate of Nicklin;
- Aboriginal and Torres Strait Islander housing;
- · Crisis accommodation centres; and
- Community renewal schemes.

The committee recommends that the proposed expenditures for the portfolios of the Minister for Transport and Minister for Main Roads, the Minister for Innovation and Information Economy and the Minister for Public Works and Minister for Housing be agreed to by the Legislative Assembly without amendment.
