Report to the Legislative Assembly

INTRODUCTION

Pursuant to Standing Order 167(3), the Legislative Assembly, by Order made on 3 June 2009, referred to Estimates Committee B for investigation and report certain proposed expenditures contained in the *Appropriation Bill 2009*. Organisational units within the portfolios of the following Ministers were allocated to Estimates Committee B:

- Deputy Premier and Minister for Health
- Minister for Police, Corrective Services and Emergency Services

The Appropriation summary for 2009–2010 for the units being reported on by the committee is in the table below.

DEPARTMENT OF HEALTH

Key funding initiatives for the Department of Health in 2009-10, include:

- total funding of \$125.7 million capital and \$19.5 million operational over three years, to expand emergency departments
- \$13 million additional operational funding (\$69.9 million operational and \$14.7 million capital total funding over four years) to expand rehabilitation and step down facilities
- \$7.9 million total operational funding over three years for more Nurse Practitioners
- \$110 million over three years to provide an additional 20,000 elective operations
- \$12.3 million operational funding in 2009-10 (Total funding of \$37 million operational and \$6.5 million capital funding over three years) to enhance cancer services
- \$4.9 million operational and \$1 million capital funding (Total funding of \$16.7 million operational and \$26 million capital over three years) to improve services for mothers and babies
- \$0.25 million additional operational funding (\$1.1 million over four years) to deliver new

- continuation of the Ipswich Hospital expansion and the expansion of the current developments at the Townsville and Rockhampton Hospitals.

- \$1.2 million for 24-7 police officer coordination in the Metropolitan Traffic Management Centre and throughout the traffic incident response system.

DEPARTMENT OF COMMUNITY SAFETY

The recently formed Department of Community Safety supports healthy, safe and secure communities through public safety, emergency management, essential emergency response services, and secure and appropriate corrective services.

The Department incorporates Queensland Corrective Services (QCS), Emergency Management Queensland (EMQ), the Queensland Fire and Rescue Service (QFRS), the Queensland Ambulance Service (QAS), the State Emergency Service (SES) and Rural Fire volunteers.

Key funding initiatives for the Department of Community Safety in 2009-10 include:

- 50 additional ambulance officers
- \$20.9 million for 150 ambulances
- four new fire stations and six replacement or redeveloped facilities
- \$10.4 million for 23 new or replacement urban fire and rescue appliances
- \$4.4 million for 34 new or replacement rural fire appliances
- \$2.5 million to manage growth in demand for Probation and Parole services and to improve supervision and reparation to the community
- \$164 million for the first stage of the South Queensland Correctional Precinct at Gatton
- \$199 million for the expansion and redevelopment of Lotus Glen Correctional Centre
- \$1.2 million for vehicles, floodboats and trailers for the SES
- \$54.9 million to build, at a total cost of \$78.7 million, a new integrated communication and emergency operations centre at Kedron
- \$0.37 million to develop and implement a QAS Vulnerable Clients Program
- \$1.4 million to continue the Sexual Offender Treatment program
- a one off donation to Surf Life Saving Queensland (SLSQ) of a twin-engine EC135 helicopter valued at \$6 million
- \$4.8 million over four years for the provision of fire reflective curtains and the replacement of petrol driven pumps with diesel driven pumps in 965 rural fire appliances

STATEMENT OF RESERVATION

Health

Secretary of Committee B

I refer to the draft report for Estimates Committee B and submit a statement of reservations on the report and some general comments on the process of Estimates Committees hearings.

General comments on the Estimates Process

The Estimates Process is the greatest opportunity for parliamentary scrutiny of Government appropriations in a unicameral system and it is unfortunate the process does not allow for well considered deliberations by parliamentary committees such as this one.

The inherent processes of the Estimates process fail to provide the level of scrutiny of the Government's use of taxpayer's money.

The limited number of questions without notice allocated to each Minister fails to ensure that committee members have the opportunity to prepare adequately for the Committee's hearings particularly in areas where the budget papers provide very little information.

The limiting of information to these Estimates Committees, both in terms of the limited useful information in the Budget Papers, as well as the limited number of questions on notice does not in any way assist the committee's work.

In addition to the information available to the committee prior to the committee's hearings there is limited time for members of the committee to gain detailed information from Ministers during the process.

During this session there has been a continuance of the disturbing trend of Ministers failing to answer specific questions from some committee members, instead giving a very general answer, which had been pre-prepared, about Government directions or policies.

As a result I have very significant reservations about how informed the Committee's report is.

Health

With consideration complete for the Health portfolio the following reservations are held –

- The Minister was vague and irrelevant in his approach to answering many serious questions about the ailing and struggling Health system.
- It is very serious and concerning that the Minister revealed there was an empty and unused hyperbaric chamber at RBH which has cost Queensland taxpayers in excess of \$6 million.
- It was disappointing to hear the Minister ruled out addressing the hospital bed shortfall in Queensland, following discrepancies between supposed bed increases and population growth.

- It is totally astounding that at the Estimates Hearing, the Minister refused to say he would publically release weekly radiotherapy waiting times despite a document being tabled that showed such information can be collected
- The Minister's approach to being held accountable is far from adequate.
- The Estimates process has failed to allow for any real analysis of the expenditures detailed in the Queensland Budget Statements for Health in particular.
- Once again the failure of Estimates Committees to allow direct questioning of Senior Public Service administrators is a serious thereat to departmental accountability.
- The appalling avoidance tactics of the Health Minister replying to questions in such a way as to evade the issue being scrutinised was a consistent theme throughout the HEALTH hearings.
- Despite numerous follow up questions and repeating the question the Minister either avoided answering questions completely or simply read prepared unrelated statements on subjects not related to the issues raised in the estimates process.
- The Minister revealed a lack of consistent and adequate reporting by Queensland Health.
- The budget papers were significantly reduced in detail from previous years and were lacking in proper detail to allow for a proper consideration of the budget.
- The Minister indulged in the blame game and refused to accept responsibility for the dire situation our health system finds itself under Labor let alone outline how the Minister would address the problem.
- The Minister used partial statistics in responses to questions on notice that did not allow for an appropriate analysis of available data.

STATEMENT OF RESERVATION

Police and Corrective Services

Police and Corrective Services

With consideration complete for the Police and Corrective Services portfolio the following reservations are held –

- The length of time available for consideration of each of the areas under consideration was unrealistic and to short to allow for a proper consideration of the portfolio areas.
- The grouping of corrective services in with emergency services limited the committee's ability to give proper consideration to the area.
- The Minister was evasive and confrontational in his approach to answering some questions.
- With a \$1.7 billion budget for police alone, it was disappointing to be given only three blocks of non-government questions to examine the budget.
- The budget papers were significantly reduced in detail from previous years and were lacking in proper detail to allow for a proper consideration of the budget.
- The Minister used partial statistics in responses to questions on notice that did not allow for an appropriate analysis of available data.

STATEMENT OF RESERVATION

Department of Community Safety (Emergency Services)

Secretary of Committee B

I refer to the draft report for Estimates Committee B and submit a statement of reservations on the report and some general comments on the process of Estimates Committees hearings.

General comments on the Estimates Process

As a result I have very significant reservations about how informed the Committee's report is.

Emergency Services –

With consideration complete for the Emergency Services area within the Department of Community Safety portfolio the following reservations are held –

- I express my disappointment at the Minister's admission that there are no new community safety programs funded or planned.
- The Minister's answer to my question regarding the additional cost of further modifications to the AW139 helicopters did not include a cost for the additions such as the stretch systems.
- The Minister's answer to my question regarding how much money was allocated to high-rise training for QFRS did not include a cost.
- The Minister's answer to my question regarding the cost of "PR flights" did not include a cost and an explanation as to why these 'operationally important' flights included a television cameraman to film the embarked Minister/Premier.

It is appreciated that the Department Officers present clearly had prepared for many more lines of questioning and it is regretted that the Estimates process does not allow for more of this detail to be raised.

While I know the Minister thinks my questions perhaps trivial and petty, I believe his attitude reflects poorly on his position and shows contempt for the Chair and the Estimates process.
