An Act authorising the Treasurer to pay amounts from the consolidated fund for departments for the financial years starting 1 July 2018 and 1 July 2019

The Parliament of Queensland enacts—

1 Short title

This Act may be cited as the *Appropriation Act 2018*.

Note—

Under the *Financial Accountability Act 2009*, section 5, words used in this Act that are defined under the *Financial Accountability Act 2009* have the same meaning the words have in that Act, subject to a contrary intention in this Act.

2 Appropriation for 2018–2019

- (1) The Treasurer is authorised to pay \$53,203,950,000 from the consolidated fund for departments as itemised in schedule 1 for the financial year starting 1 July 2018.
- (2) For each department, the vote amount mentioned for the department in schedule 2 is appropriated for the financial year for the department for application to its departmental services, equity adjustment and administered items as stated in schedule 2.
- (3) The amount mentioned in subsection (1) includes the amount already authorised by the *Appropriation Act 2017*, section 3, to be paid for the financial year starting 1 July 2018.

3 Supply for 2019–2020

The Treasurer is authorised to pay \$26,601,975,000 from the consolidated fund for departments for the financial year starting 1 July 2019.

4 Repeals

The following Acts are repealed—

- Appropriation Act 2016, No. 41;
- Appropriation Act (No. 2) 2016, No. 55.
