Mr Elliott tabled a letter from the Clerk of the Parliament and an unsigned opinion from the University of Queensland Law School which provide the opinion that section 9 of the *Public Accounts Committee Act 1988* confers all the powers on the Deputy Chairman in the absence of the Chairman and that includes the power to call a meeting of the Committee.

Mr Elliott detailed two other independent opinions (verbal) in support of his power as Deputy Chairman to call a meeting of the Committee, one from staff with a legal background in the Parliamentary Library.

Mr Elliott ruled that the meeting was in order based upon the weight of this advice.

Minutes of Previous Meeting

Minutes of the meeting of 18 May 1993 were circulated and confirmed on the motion of D'Arcy, seconded Santoro.

Correspondence

Mr Dahms informed the Meeting that most of the correspondence inward concerned replies to the Committee's questionnaire concerning the standard of preparation of departmental financial statements and that all correspondence could wait until the next meeting at which the Chairman would be present.

Agreed that the correspondence be held over until the next meeting at which the Chairman would be present.

Gold Coast Motor Events Co

Mr Dahms informed the meeting that the Auditor-General had replied to the Chairman's letter of 19 May 1993 referring to him matters raised by Mr

McPhillimy concerning the Indy Car Race and placed before the Committee by Mr Grice. The Auditor-General informed the Committee by letter dated 3 June 1993 that he would examine the details raised by Mr McPhillimy and act on any details which he believes are audit related.

Committee Travel

Ms Stolz placed before the meeting details of the travel itinerary to Aboriginal and Island Councils for July 1993.

Mr Dahms supplied preliminary details for the Chairman's proposed travel to New Zealand in July 1993. He was requested to determine dates of hearings to be conducted by the New Zealand Finance and Expenditure Committee into bills and estimates. Members thought all the Committee should be included in this travel. Mr Dahms was requested to seek advice from the Chairman as to the size of the delegation he had in mind. Details of these matters were to be faxed to Members as soon as possible.

Queenslands Ambulance Service

Mr Elliott raised issues included in the Interim Report of the Public Sector Management Commission into the Queensland Ambulance Service and the question of the accuracy of reporting in the 1991/92 Annual Report of the Bureau of Emergency Services.

Discussion ensued.

During the discussion it was established that, under section 13 of the *Public Accounts Committee Act 1988*, the Committee could not review the Interim Report of the Public Sector Management Commission, but it could review annual reports of the Bureau of Emergency Services.

The Research Staff provided a briefing which informed the Committee that the Public Sector Management Commission was continuing its review of the Bureau of Emergency Services and would produce its final report in late July, early August 1993; The Auditor-General is currently conducting his audit of the Bureau of Emergency Services. The Research Staff recommended that these two bodies be allowed to complete their audit/review and that the Committee subsequently review the Auditor-General's Report on Audits Performed for the Financial Year Ended 30 June 1993 and the 1992/93 Annual Report of the Bureau of Emergency Services.

Ms Stolz explained the various budget papers and financial statements for the Bureau of Emergency Services for the 1992/93 financial year.

STATEMENT BY RAY HOLLIS, M.L.A. CHAIR OF THE PUBLIC ACCOUNTS COMMITTEE.

In view of the intense media speculation concerning the release last Friday of the Public Accounts Committee's inquiry into the financing of Aboriginal communities I have decided to make this statement.

I wish to make it quite clear that the inquiry did not focus on the communities themselves but on the accountability of the Department of Family Services and Aboriginal and Islander Affairs.

This has long been an area of contention and has troubled various governments in Queensland over the past 50 years.

The only section of the report that are in question concerns Sections 82 and 83 of the Aboriginal and Islander Acts.

While the committee was of the view that the Minister for Family Services and Aboriginal and Islander Affairs and the Director-General had certain responsibilities under this section, I agree with the Minister that in a legal interpretation of this section neither she nor the Director-General are accountable under this section.

It was to this issue that my comments on the weekend were addressed.

This is a key point which has been missing from media commentary on the matter.

I cannot let this statement pass without some comments on the attitude and actions of the media.

I take the view that as a politician and as chair of the Public Accounts Committee I am open to scrutiny from the media.

However as a family man I believe strongly that my family has a right to privacy.

The strong messages of support I have been getting in my electorate office vesterds

The strong messages of support I have been getting in my electorate office yesterday following the 7.30 Report of Monday night suggest to me that the media is out of step with public attitudes in this matter, and I suggest they review their performance and act accordingly.

What I am more concerned about, however, is the way the findings of the committee have been used by members of the Opposition.

It has been used solely as a political vehicle to score political points with no regard at all to improving the quality of public administration in this state.

The Public Accounts committee is not about acting as judge, jury and executioner. What the committee is about is improving the quality of public administration. It is a committee concerned with improving the quality of public administration for the

future, not pointing the finger at events in the past.

For the committee system to work effectively it needs the commitment of all members to its proper workings.

The actions of the Opposition last Friday showed that they undoubtably had prior knowledge of the contents of the report before it was released, and as such, the integrity of the committee system was damaged.

It has and always is my intention to provide accountability as a prime focus of this government. I will continue as chair of this committee and trust that Opposition members of this committee will join me in achieving this aim in a bipartisan fashion.

The Public Accounts Committee met at length today to deliberate on the issue of the Chairman's comments subsequent to the release of the Report into the financial administration of Aboriginal and Island Councils.
